

RESOLUTION NO. 2021-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CUMBY, TEXAS, APPROVE THE RESIGNATION OF JULIE MORRIS, ALDERMAN, PLACE 5 AND CODI REYNOLDS, CITY SECRETARY, APPOINT Ryan Horne AS ALDERMAN, PLACE 5, AND APPROVE ADVERTISING FOR THE POSITION OF CITY SECRETARY

WHEREAS, on January 28, 2021, by Motion approved the Resignation of Julie Morris, Alderman, Place 5 and Codi Reynolds, City Secretary; and

WHEREAS, Julie Morris called Doug Simmerman, Mayor, and posted on the Social Media Platform, Facebook that she was resigning from her role as Councilmember in Alderman Place 5 as of January 19, 2021; and

WHEREAS, Codi Reynolds sent Doug Simmerman, Mayor, an email on January 21, 2021 resigning her post effective immediately; and

WHEREAS, on January 28, 2021, by Motion named Ryan Horne, to serve as Alderman, Place 5; and

WHEREAS, on January 28, 2021, by Motion, approved the proposed job description for City Secretary as well as the advertisement for the position of City Secretary;

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CUMBY THAT:

SECTION 1 – APPOINTMENT AS ALDERMAN 5

The City Council of the City of Cumby, Texas, does hereby appoint Ryan Horne to serve as Alderman 5, until the expiration of the term.

SECTION 2 – APPROVAL OF ADVERTISING FOR NEW CITY SECRETARY

The City Council of the City of Cumby, Texas, does hereby approve the employment search for the position of Cumby City Secretary and authorizes the search be published in a way that advertises the position in a way to reach the best candidates.

SECTION 3 – REMOVAL OF JULIE MORRIS AND CODI REYNOLDS FROM ALL CITY FINANCIAL ACCOUNTS, SECURITY ACCOUNTS, AND ANY AND ALL OTHER CITY RELATED ACCESS THAT PERTAINED TO OFFICIAL DUTIES

The City Council of the City of Cumby, Texas, does hereby approve removing Julie Morris and Codi Reynolds from any and all City financial accounts, security accounts or access, and any and all specialized access that occurred or was acquired in relation to their official City duties.
